LICENSE

AntWordProfiler 2.0 and any minor updates issued by AntLab Solutions within the same major version number (collectively, the "Software").

TERMS GOVERNING THE USE OF THE SOFTWARE

The Software is protected by copyright and is licensed, not sold. Your rights to install, access, and use the Software are limited to those expressly granted in this License. By installing or using the Software, you agree to be bound by the terms of this License. This license is made between AntLab Solutions, Tokyo, Japan, as licensor, and you, as licensee, as of the date of your first use of the Software. 1. License Material

2. License Grant
